I live in South Australia and am submitting feedback because I want to live in a Tiny House on Wheels (THOW) legally.

I am choosing to live in a THOW for two main reasons: housing affordability - rent and mortgage options are too costly and to lessen my footprint on the environment - less resources needed to construct and energy required to run the house.

My plan is to initially lease a small parcel of land from a private land owner, without access to services as I plan to be off-grid. This will allow me to save funds to purchase a piece of land in the future and move my portable THOW to live permanently.

Council planning departments' classification of a THOW varies immensely from one council to the next - everything from being classed as a caravan to an out building, and as such, I am unable to legally reside permanently in it when parked on leased private land.

Council planners have stated that they do not possess codes to allow THOW living in their area or the state.

I know of many South Australians, and people in other states, who either reside in a THOW (by default, illegally) or wish to do so but cannot commit to a THOW because of the placement insecurity.

The THOW movement has grown and will continue to grow to be an attractive housing option to many people for many different reasons.

This is clearly illustrated by the interstate/worldwide growth of TH manufacturers, TH communities and families now living in THOW.

I wish to submit to the Planning Commission that amendments to the new planning codes are MADE to allow South Australians to take advantage of this exciting and innovative form of shelter and to give councils specific planning tools to allow this to take place in a safe and legal manner.
